## VA High LTV Refinances

As a reminder, VA full doc refinance transactions with LTVs greater than 90% must be delivered to PennyMac by September 30, 2019. In addition, these loans must be purchased by October 10, 2019, and all loans must have a first payment due date no later than November 1, 2019.

## **Retiring AOT**

Effective **Tuesday, October 1, 2019**, PennyMac will stop accepting new AOT rate lock commitments. Commitments received before this date will be processed as normal. In addition, PennyMac will discontinue AOT-DT rate sheet distribution as of the effective date.
