Temporary Buydown Eligibility Expansion

Effective August 28, 2026, Pennymac is excited to announce a significant expansion to our temporary buydown offerings. These updates introduce updated credit score requirements and clarified guidelines across eligible GSE, FHA, and VA products.

Key updates include:

- **Minimum Credit Score Updates:** Minimum FICO requirements have been lowered across Fannie Mae, Freddie Mac, FHA 203b, and VA Manufactured Home programs. Generally, the minimum requirement is 620 FICO for total rate reductions of 2% or less, and 660 FICO for reductions greater than 2%.
- **Expanded Eligibility:** The overlay disallowing temporary buydowns on manufactured homes has been removed for applicable GSE programs.
